

- Four Seasons School's summer camp program is divided into two four-week sessions. Please note the payment due dates for each session.
- You must enroll your child for the same days and times each week. You must register for all weeks in Session I and/or all weeks of Session II.
- You may also choose T/TH, M/W/F or 5 days for each week enrolled at any age level but they must be consistent each week.
- The camp day begins at 8:30am and ends at 12:30pm. Before and after care is available. See tuition chart.
- Four Seasons School's summer camp accommodates children ages 1 year through PreK or recently completed FSCP Pre-K.
- Please complete the attached Summer Camp Application form for your child/children.
- Remember to include your child's <u>name and birth date</u>, <u>days attending and arrival and pickup times</u> for each day. Please use the tuition chart to help you determine the sessions, days, and hours you will need.
- Summer camp <u>only</u> is charged as follows: \$45.00 Registration, \$50 Maintenance Fee + Activity fee based on the chart below:

- For Four Seasons School to provide adequate staff for each session, please keep the following guidelines in mind:
 - o Enrollment changes must be made by April 15th. No change requests will be granted after April 15th
 - o A change fee of \$25 per week per child is required for any changes to your child's enrollment such as sessions added and/or dropped, time changes, etc.
 - o Tuition payments are to be made, in full, for each session. If payments are not received by due dates, you will forfeit your child's spot.

CURRENT FAMILIES

- Currently enrolled 10-month students must pay the Registration Fee, Maintenance, Activities Fee and 50% of Session I upon Registration. The remaining 50% is due May 1.
- Currently enrolled 12-month students must pay the Activities Fee upon Registration.

NEW FAMILIES

- New Enrollees registered for summer only must pay Registration Fee, Maintenance Fee, Activities Fee and 1st
 Tuition payment for Session I at the time of registration.
- Session II for weeks 5-8 tuition payment is due on June 1
- Upon receipt of your completed camp enrollment form, you will receive confirmation of your enrollment including a tuition breakdown and payment schedule.



All tuition starting times are 8:30am. Before Care is available starting at 7:15am. Four Seasons Childcare & Preschool offers a 5% discount for each student sibling enrolled. The tuition chart reflects the four-week tuition rates for summer camp only.
